3/10/04 Board Meeting Notes

The following represent the highlights of approved issues by the Board. Attendance: Sue G, Jeff K, Scott K, Howard H, Helen P, Terri S. Absent: Betty C and Ginger M - Helen reported that Ginger said she will be resigning but no letter of resignation has been received yet.

1) Sue asked for a change in officers - Jeff to be Vice President and Scott to be Treasurer to better reflect their respective duties (approved), 2) Approved bid to have RGM Ser-

vices work on sound-proofing furnace room in back building, 3) Sue will get bids for carpeting in back building, 4) Jeff & Helen will be co-chairs for spring cleaning date, 4) reviewed and approved detailed financial report (see summary below), 5) Meeting income revenue report reviewed, 2 groups have not paid rent since mid-January; board members will contact groups 6) established \$10 standard rate for rent per meeting (approved by Board) - if groups can pay this much, great; if they can't, Club will use other income sources to help meet these costs as they always have in the past, 7) another lifetime membership plaque will be purchased, 8) Approved bid to have Tom M repair siding and ramp, 9) Scott & Jeff will set up time to view apartment upstairs with renters to

identify repair needs reported by renter, 10) discussion on rate of rental for upstairs apartment, 11) Helen & Terri reviewed their "Volunteer Guidelines" and "Phone Lists" to have available for volunteers working in the club as resources, wondering if others may be interested in volunteering additional 3 hour shifts during the daytime to open up the club more often (see back), 12) purchase an "OPEN" lighted sign to put in window of club, 13) Terri will coordinate a supply ordering list. **NEXT MEETING, WED. APRIL 14TH AT 7:00 PM.**
