## 7/13/05 Board Meeting Notes

(1) Board minutes approved from 6/8/05; (2) Reviewed June financials (see below); (3) Reviewed board member attendance; (4) Approved a transfer of funds from savings to checking to cover cash-flow issues in mid-late July; (5) Reviewed summer attendance report during Club hours (see right); (6) Building & Grounds update - clarification on tasks to address include developing "options" with as much detail as possible to present to the general mem-

bership for their decision (see back for current options being looked into); also updated on 9 foot property issue that was discovered when reviewing property description paperwork, an attorney has been contacted about drafting appropriate documentation to seek resolution of this issue (attorney fees being donated); (7) Discussion about final Venetian fundraising plans of selling smoothies, chili dogs, cookies, soda and water, Terry brought smoothie and cookie samples for the board to taste; (8) Summer bowl-a-thon has been cancelled due to lack of interest, several people that were expected to be interested in bowling were not and other potential donors reported it was too soon to do again; (9) Reviewed information received from the "Michigan Alano

League" that met in Grand Rapids in May where representatives from various Alano Clubs in Michigan got together and compared notes, interesting to compare membership dues and issues they are being faced with - dues in Charlevoix slightly lower than most but all other issues are similar in membership retention, fundraising, building & renovation of older buildings, etc.; (10) reviewed AA 2004 Membership Survey that was published in the Grapevine (see back); (11) Encouraging board to seek volunteers for Venetian and attempt to increase attendance at Open Speaker meetings due to such low turnout at the past two meetings.
