#### Financial Report ~ Treasurer

## The total revenue for Serenity House in 2024 is \$32,381.

The total expenditure for Serenity House in 2024 is \$25,740. Leaving us with positive Net Revenue of \$6,644 in 2024.

The actual net revenue was \$6,644, while the budgeted net revenue was -\$5,099, resulting in a positive difference of \$11,743.

The total donations income for Serenity House in 2024 is \$16,636.

The memorial donations for Serenity House in 2024 are \$3,985.

The total donations from our appeal letter were \$9,975. I will bring the 2025 budget to our February meeting for approval.

We have not yet received the 4th Quarter Financial Statement from CCCF. I will report that as soon as we receive it.

- The current balance of the Charlevoix Alano Club Fund is \$208,789
- The balance of the 3rd Quarter of the Charlevoix Alano Club Fund was \$210,795; a difference of \$2,006

The total amount of payments paid is \$1,606.45. The total amount of deposits cleared is \$6,967.75. The balance as of 12/31/2024 is \$16,013.55.

- Carpet cleaned on 11/21/24
- Carbon Monoxide detectors purchased and installed.

Waste management will come to building and pick of trash. \$84/month. Tote service. Biweekly. They supply 96-gallon bin. Discussion about cleaning person hauling trash. Kendra will order a bin. Motion to pay for trash removal service, second – Deb. Approved. Motion passed.
- Superbowl party. No cable to have party. Attendance was low last year. It was potluck style last year. No gambling on premises unless it is a fundraiser. In the future it will be done by CAAAG. Will suggest to person to present to CAAAG.
- File cabinet for information in the basement that must be sorted. Kendra and friends will complete this task.
- Kendra complimented by board for all her service work.

Year End Appeal Letter Update - Luther K and Deb. This went well.

Sound Downstairs – Tom C: Conversation with Mike C. There are ways of putting speakers in the basement. Proposal to buy an I-pad for \$320 to have visual and sound. This will help accommodate those who bring children to meetings. It was suggested to install speakers due to concerns about theft and children being too loud. Kevin has an extra that he could donate.
